A person may be considered a dislocated worker if he or she:

\_\_\_\_\_ Is a displaced homemaker. A displaced homemaker is a person who previously provided unpaid services to the family (e.g., a stay-at-home mom or dad) is no longer supported by the husband or wife, is unemployed or underemployed, and is having trouble finding or upgrading employment.
