

SE CARES Act Report

Southeastern Oklahoma State University

Report Period Ending: March 31, 2022

Background

The Emergency Financial Aid Grants to Students under the Coronavirus Aid, Relief, and Economic Security (CARES) Act Section 18004(a)(1) of the CARES Act, Pub. L. No. 116-136 signed on March 27, 2020, you may be eligible for a portion of the CARES Act Student Emergency Funds. These funds have been designated to provide emergency financial aid grants to students for expenses related to the disruption of campus operations due to coronavirus (including eligible expenses under a student's cost of attendance such as food, housing, course materials, technology, health care, and childcare).

As part of the reporting requirements by the Department of Education, Southeastern Oklahoma State University is responding to the following items provided by the federal government.

Item 1

An acknowledgement that the institution signed and returned the certification and agreement form and that the institution has used or intends to use the funds to provide the mandated amount of at least 50% of the emergency financial aid grants to students.

- Southeastern Oklahoma State University signed and returned the certification and agreement form on April 14, 2020.

Item 2

The total amount of funds that the institution will receive or has received under the HEERF student portion.

- As of March 31, 2022, no additional activity.
- As of December 31, 2021, no additional activity.
- As of September 30, 2021, no additional activity.
- Southeastern Oklahoma State University received \$3,652,815 under the HEERF III student portion of the CARES Act.
- Southeastern Oklahoma State University received \$1,059,075 under the HEERF II student portion of the CARES Act.
- Southeastern Oklahoma State University received \$1,059,075 under the HEERF student portion of the CARES Act.

Item 3

Of those funds, the total amount that has been distributed to students as of the date of reporting (i.e. the first 30-day deadline, and then every 45 days thereafter).

- As of March 31, 2022, no additional activity.
- As of December 31, 2022, \$1,826,407.50 has been distributed to eligible students from Student CARES funds.
- As of September 30, 2021, no additional activity.
- As of June 30, 2021, \$1,059,075 has been distributed to eligible students from Student CARES funds and \$162,925 from Institutional CARES funds.
- As of May 8, 2020, \$1,059,075 has been distributed to eligible students.

Item 4

The estimated total number of students at the institution eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965 and therefore eligible to receive an emergency financial aid grant.

- As of March 31, 2022, no additional activity.
- November 2021 – Based on federal guidance, the number of students eligible to receive the emergency financial aid grant was 5422.
- As of September 30, 2021, no additional activity.
- April 2021 - Based on federal guidance, the number of students eligible to receive the emergency financial aid grant was 5148.
- May 2020 - Based on federal guidance, the number of students eligible to receive the emergency financial aid grant was 2557.

Item 5

The total number of students who have received an emergency financial aid grant.

- As of March 31, 2022, no additional activity.
- November 2021 – The total the number of students who received the emergency financial aid grant was 5422.
- As of September 30, 2021, no additional activity.
- April 2021 - The total number of students who received the emergency financial aid grant was 5148.
- May 2020 - The total number of students who received the emergency financial aid grant was 2557.

Item 6

How the institution determined which students did or will receive emergency financial aid grants and how much funding they did or will receive.

- As of March 31, 2022, no additional activity.
- November 4, 2021 Disbursement
 - Student's amounts were determined based on having an EFC that is Pell eligible.
 - Non-Pell eligible/No FAFSA Students received \$302.00
 - Pell Eligible Students received about \$402.00
- As of September 30, 2021, no additional activity.
- April 6, 2021 Disbursement
 - Student's eligibility is based on having an EFC that is Pell eligible. International students (international students (except for those possessing a permanent resident card-Green Card) and DACA students were not eligible.
 - Students with a Pell eligible EFC received \$300. Students who were not Pell eligible or did not apply for Federal Financial Aid (but was eligible to), received \$200.
- May 8, 2020 Disbursement
 - Student's eligibility is based on their ability to apply for or have previously applied for Federal Financial Aid or Title IV aid such as Pell, SEOG, Federal Work-Study, Student Loans. Based on Federal guidance, concurrent students, students who previously identified as a felon, international students (except for those possessing a permanent resident card-Green Card), and students enrolled in fully online programs were not eligible.
 - The amount was calculated based on each student's number of credit hours enrolled as of March 13, 2020 multiplied by a per credit hour rate – generally between \$33.00 and \$34.00 per credit hour.

Item 7

Any instructions, directions, or guidance provided by the institution to students concerning the emergency financial aid grants.
