

## **ACADEMIC APPEALS**

### **August 16, 2018**

**MEMBERS PRESENT:** Bryon Clark (Ex-Officio), Kathy Boothe, Linda Bressler, Diane Dixon, William Fridley, and Karl Frinkle

The meeting was called to order by Karl Frinkle in Room 302 of the Administration Building.

The first item on the agenda was to approve the minutes from the May 31, 2018 meeting as well as minutes from the online vote on July 10, 2018. William Fridley noted a correction to the date on the July 10 minutes and made a motion to approve the minutes with that correction. The motion was seconded by Diane Dixon and passed unanimously, 5-0.

The second item on the agenda was immediate reinstatement requests. They were as follows:

A student submitted a grade change of "F" to "W" in POSC 1513 taken in Summer 2018. A motion to **deny** was made by Kathy Boothe and seconded by Karl Frinkle. The motion passed 5-0.

A student requested a grade change of "F" to "W" or "F" to "A" in SOC 3523 taken in Fall 2017. A motion to **deny** was made by Kathy Boothe and seconded by Linda Bressler. The motion passed 5-0.

A student requested a grade change of "F" to "W" in FIN 3113 taken in Summer 2018. A motion to **approve** was made by Diane Dixon and seconded by Karl Frinkle. The motion passed 5-0.
