

# ***Teacher Education Council Meeting Minutes - Approved***

April 19, 2018

## **I. Call to order**

Dr. Stewart Mayers called to order the regular meeting of the Teacher Education Council at 4:02 pm on April 19, 2018 at in Morrison 205.

## **II. Roll call**

## **III. Approve Minutes from March meeting**

Dr. Stout made a motion to approve the March meeting minutes. Dr. Morrison requested the spelling of Jon Hazell's name be corrected. The motion was seconded by Ms. Delashaw and approved by all in attendance.

## **IV. Proposed modification to EDUC 3002 and 4000**

Drs. Mayers and Stout introduced the proposed revision to EDUC 3002 and EDUC 4000. Dr. Mayers explained the number of hours for 3002 would be reduced from 75 to 50. Dr. Stout explained the concept of connecting 3002 to student teaching by having the student's placement for 3002 in the classroom in which s/he will student teach. Dr. Stout further explained the need for student teachers to see the entire school year, both beginning and the end. the flexibility of being able to change a student's placement between 3002 and student teaching if the need arises, a decision that would be made by Drs. Stout (non-music ed majors) and Walker (music ed majors). Dr. Walker moved to approve and Ms. Fridley seconded. The motion carried unanimously.

## **V. Proposed procedural modification to EDUC 2000**

Dr. Mayers suggested changing the placement selection procedure in EDUC 2000 from student selection to assignment by Dr. Williams (professor of record for the course), Dr. Stout, Coordinator of Field Experiences, and the TES staff (Ms. Collins and Ms. Arnold). The reason for the proposal was to streamline the process of ensuring that student placements for EDUC met all of the sub-population criteria required by CAEP. No motion was needed, but all approved.

## **VI. Other New Business**

Dr. Mayers announced the addition of Ms. Jill O'Neal, Director of Human Resources for the Sherman ISD to the SE Teacher Education Council. This appointment came about after a conversation on Tuesday, April 17, between Dr. Mayers and Dr. David Hicks, superintendent of the Sherman ISD. We look forward to a long and fruitful partnership with the SISD.

Mr. Jon Hazell announced he had been working with local business leaders to secure funding for scholarship for students who were either juniors or seniors who had been admitted to teacher education and who planned to teach in Oklahoma. Mr. Hazell said his group has \$5000 to award for next year and would like to award either two \$2500 scholarships or four \$1250 scholarships, based on need. Dr. Matthews recommended, and the Council agreed, that guidance from Vice President Stafford's office on how to proceed was in order. Dr. Mayers agreed to email VP Stafford and Ms. Bryanna Allsbury of the scholarship office for guidance.
