I. Call to Order

Dr. Jerry Stout called the meeting to order at 3:01 pm.

II. Review of Minutes of Previous Meeting

Dr. Jon Reid motioned to approve the minutes, and Dr. Alluisi seconded the motion. Unanimous consent was heard, and the motion passed.

III. Enrollment Numbers

The current enrollment data for graduate programs was given and remarked upon.

IV. Graduate Appeal—Student

The appeal is to accept courses older than six years. Dr. Moore motioned to approve the graduate appeal, and Dr. Walker seconded the motion. With 11 votes in the affirmative, one vote in the negative, and zero abstentions, one vote against, the motion passed.

Dr. Reid motioned to deny the approval, and Dr. Bressler seconded the motion. With 13 votes in the affirmative and zero abstentions or votes in the negative, the motion passed.
